1. The Contributor undertakes agrees and confirms:

- . 1.1 That the contributor is entitled to enter into this agreement and is not bound by and will not enter into any agreement which might prevent or inhibit the contributor from performing the contributor's obligations under this agreement.
- . 1.2 That nothing in the contributor's contribution will infringe any rights of any nature of any third party and / or be obscene or blasphemous or defamatory and / or bring the producer into disrepute.
- . 1.3 That the producer will own all rights (including without limitation the copyright) of every kind in and to all film, tape, audio, and audio-visual recordings, any transcripts of such recordings and photographs (collectively referred to as "the Materials") made in respect of the contributors contribution under this agreement. Without limitation to the foregoing, the producers rights will include the irrevocable right to exploit any and all of the materials in all formats (including but not limited to analogue and digital) and media (including but not limited to cinema, video, pay television, free television, print and the internet) now known or hereafter invented throughout the world for the full period of copyright (including all renewals or revivals of copyright). The producer may itself refer and authorise others to refer to the contributor and use the contributor's name, likeness, photograph and biographical information in any advertising and publicity relating to exploitation of the programme, the materials and / or the contributor's contribution. The producer's rights under this agreement shall apply to the whole or any excerpt(s) of the materials and the contributor's contribution. Nothing in this agreement shall constitute an obligation on the producer to exploit the materials and / or the contributor's contribution.
- . 1.4 That the contributor hereby irrevocably and unconditionally waives all moral rights in respect of the materials and / or the contributor's contribution that the contributor may now or in the future be entitled to under the copyright and related act, 2000 and any similar laws throughout the world.
- . 1.5 That to the extent (if any) that the contributor's contribution under this agreement constitutes a performance, the contributor hereby irrevocably and unconditionally, grants to the producer all assignments, consents and waivers in respect of the performance as are necessary under the copyright and related rights act, 2000 and any similar laws throughout the world to permit the exploitation of the performance in all formats and media now known or hereafter invented throughout the world (including without limitation cinema, video, pay television, free television, print and the internet) in perpetuity without payment to, or approval from, the contributor.
- . 1.6 That the contributor will indemnify the producer from and against all costs (including reasonable legal fees), damages, losses and claims whatever incurred by the producer in settling, defending or otherwise properly disposing of any third party claim arising as a result of any breach by the contributor of the contributor's obligations and / or undertakings under this agreement.
- . 1.7 The producer will not be liable to the contributor or the contributor's personal representatives for any loss, damage or injury to the contributor's person or property or in connection with the contributor's contribution under this agreement unless caused by the negligence of the producer.
- . 1.8 The producer may transfer, assign, license, mortgage and charge the producers rights under this agreement.
- . 1.9 This agreement is governed by the laws of Ireland and the parties agree to the exclusive jurisdiction of the courts in Ireland.
